² For example: For 4.5 acres, for a 6-month duration permit, the Fee for the first acre included is \$455 and the remaining 3.5 acres is rounded up to 4 acres, then multiplied by \$46/acre, and equals \$184. And, the two amounts combined equal the Review Fee Total of \$639.
